

**FATİH PROJECT POSITION PAPER****TABLET PC****INTRODUCTION**

“The Movement of Raising Opportunities in Education and Improving Technology” (FATİH) Project has been launched in line with the targets defined in the Ninth Development Plan, Information Society Strategy and Ministry of Education Strategic Plan and with the purposes of effective use of information technology in the process of education, development of qualified human resources and fulfilling the necessities of our age. FATİH Project Commission has been established to plan the process of Project.

FATİH Project is planned to be extended to countrywide within the period of 2011-2014. It is planned with the project to provide about 570,000 interactive smart boards to primary and secondary level schools, about 11,136,752 tablet PCs to the students, 715,000 tablet PCs to teachers and establish the necessary internet infrastructure in about 620,000 classrooms in order to provide equality of opportunity in education, improve technology in schools and use the instruments of information technology effectively in the process of education.

Tablet PC's will be continued to be provided to 1.3 million students that will join the education system every year and interactive smart boards will be continued to be distributed to the 15,000 newly opened classrooms every year, following the year 2014.

**OBJECTIVE:** Development of the human resources equipped with the essential technological skills by means of efficient use of information technology hardware and applications in education and diversification and improvement of education materials.

**STRATEGICAL TARGET:** Taking into consideration the objectives stated in the National Strategy documents and the components/indicators included in the FATİH Project;

To materialize the necessary investments for the production of the technology, intellectual property rights, goods and services subject to the Project in Turkey; increasing the level of production and value-added; acquisition of technology; continuation of the research and development activities oriented to new technology and new products and transition to the information society.

**CALL FOR PROJECT:** It is expected that the companies/consortiums will answer the questions stated in Annex-1 in and present their work plans to the Commission in a concrete, thorough and satisfactory manner until February 1<sup>st</sup>, 2012. Although it is not obligatory for the companies/consortiums to provide answer for all the sub headings, it is important to emphasize that the final assessment to be made by the Commission about competency/proficiency will be based on the answers given to all questions.

**ECONOMIC INDICATORS:**

As an important market in Project related products and components, Turkey carries a potential of becoming an important production and export base within the region.

In 2010, in Turkey;

- Imports of display panels were about USD 1.7 billion,
- Exports of LCD television were USD 1.4 billion,
- Electronics industry imports were USD 14.5 billion,
- Imports of computer components were USD 2.8 billion,
- Electronics industry production was USD 11.3 billion,
- Imports of mobile phones/devices were USD 1.3 billion,
- Domestic market for information technology was USD 30 billion,
- New mobile phone registrations were 15.9 million.

Moreover, imports of televisions were about USD 29 billion in peripheral countries.

The intention to attend the meetings to be organized by the Commission in February-March period should also be indicated in the applications.

**EVALUATION:** The companies/consortiums that accomplish the below mentioned points will be prioritized in the evaluation process:

- 1) The products and components that are subject to the Project are to be produced domestically with the highest possible value added.
- 2) The production under consideration is to be designed and realized not only within the scope and scale of the Project but also, concerning the needs of the domestic market and in an export oriented way.
- 3) Adaptation of investments in the products/product components subject to the Project to new technologies is to be committed.

***Below questions are posed to evaluate the degree of compliance of the companies/consortiums with those three criteria. In this respect, the answers given to below questions will be assessed by taking into account of the degree of compliance with those criteria performed by the companies/consortiums.***
